The Listing of Individual(s) and Entities in the UN Sanction List in accordance with Resolution 1267 adopted by the UN Security Council

- The Committee shall receive a request to list individual(s) or entities from Members of the Committee, Local Authorities, or Foreign Authorities.

The Committee shall send the request to the relevant Law Enforcement Agencies to provide

all the data and information available at their esteemed disposal.

- In case the data and information matched the standards of the Committee for the Implementation of Security Council Resolutions under Chapter VII of the United Nations Charter in regards of listing individual(s) or entities in The National List, the name(s) of individual(s) and entities shall be presented to Members of the Committee to hold a vote to unanimously approve the listing.

The Committee for the Implementation of Security Council Resolutions under Chapter VII of the United Nations Charter shall hold a meeting to formally ratify their decision to list the individual(s) or entities in question. The ratification shall be mentioned in the minutes

of the meeting.

The relevant authorities shall take all the needed measures to implement the listing without delays as per their professional scope.
